

Environmental exposures predict health outcomes

- Deaths are increasingly caused by diseases that linked to environmental conditions
- Pollution is the leading cause of global deaths
- People of color are disproportionately harmed by environmental conditions



What is the HEAL Act?

- The Healthy Environment for All Act passed in Washington State in 2021.
- Agencies must consider, plan for, and address environmental justice issues in a wide scope of activities.
- This means addressing environmental and health issues in WA through an equity and justice lens:
 - Prioritizing overburdened communities, vulnerable populations, and Tribes who disproportionately bear the largest environmental burdens.
 - Preventing and addressing root causes.



Incorporate EJ into budget & funding decisions

- 1. Directing 40% of grants and expenditures that create environmental benefits to overburdened communities and vulnerable populations.
- 2. Create opportunities for overburdened communities to meaningfully inform expenditure decisions.
- 3. Consider developing innovative approaches, such as:
 (i) Community grants to monitor pollution
 (ii) Grants to providing training for community involvement
 (iii) Delivering technical assistance to new beneficiaries
 (iv) Education and work readiness programs

Significant agency actions

- 1. New rulemaking
- 2. Agency request legislation
- 3. New grant or loan program
- 4. A new capital project, grant, or loan (at least \$12 million)

*Ecology will consider additional activities for 2025+







WASHINGTON TRACKING NETWORK (WTN)



Components of justice

Recognition: Affirming the inherent value of everyone involved

Procedure: Decisions and management are inclusive, participatory, trusted, and transparent

Distribution: Harms and benefits are spread fairly across space, time, and groups


Threat x Vulnerability = Risk Resources x Competencies = Capacity

Risk – Capacity = Impact



Take aways!

- Some people continue to be disproportionately impacted by policies, public administration, and social norms that inequitably protect and benefit some groups more than others.
- ✓ While the HEAL Act was a historic victory, no single tool or law perfectly addresses environmental and health disparities.
- Taking Pro-Equity Anti-Racism actions is our shared work and opportunity.
- Ecology's Water Quality program will implement HEAL Act obligations and continue to pursue anti-racist practices that create equity in our funding and regulatory decision.
